The festival committee will select vendors that will give attendees an authentic arts & crafts fair experience. The application deadline is August 31, 2024 with notification beginning August 1, 2024. Fees <u>will</u> be refunded if vendor is not accepted.

## ARTS / CRAFTS / HANDMADE VENDORS:

In addition to completing the attached *AutumnFest Vendor Application* with payment, all items sold in your booth must be as described in your application, hand crafted without the use of kits, commercial models, and whose primary components are not manufactured. Applicants must submit 3-4 images (preferably emailed to bsampson@southernpines.net) of the work that represents what you will sell at the festival. Please include a photo of your booth. Images will not be returned & may be used for promotional purposes. Applications without images will not be accepted. Vendor notifications will be sent beginning August 1, 2024. Space assignments and day-of instructions will be emailed beginning September 6, 2024.

#### **FOOD VENDORS REQUIREMENTS:**

- 1) All food vendors MUST meet health/sanitation requirements according to <u>G.S. 130A-247</u>, return the <u>Temporary Food Vendor Application</u> or <u>Exemption Permit</u> to Moore County Health Dept. & pass inspection by the Moore County Health Dept. by 9/11/24 to receive your permit.
- 2) Food Truck/Trailers must provide their own power/generator. NO ELECTRICITY is available.
- 3) Tents/trailers over 12'x12' are required to meet fire codes according to the updated Fire Safety Standards.
- 4) Maximum length for a Food Truck/Trailer is 20' including the tongue.
- 5) Food vendors must set up by 7am on October 5, or make advance arrangements with Bridgett Sampson at 910-692-7376 or bsampson@southernpines.net.

#### Reminders for a safe & successful AutumnFest:

- AutumnFest will be held, rain or shine—No Refunds.
- No alcohol, smoking, tobacco, vaping, or nicotine delivery products allowed in Downtown Park.
- Vendors must provide their own equipment (tables, tent, etc.) & remove their own trash.
- Each vendor space size is 10'x10' | Food truck maximum length is 20'.
- Not all vendor spaces will accommodate a tent or trailer, therefore it is <u>imperative</u> that you complete your application accurately (especially if your trailer or tent exceeds 12' in height).
- Register early as vendor spaces in each category are limited & fill up quickly.
- Non-food vendor space set-up time will be 5:30-8am on Saturday, October 5.
- Vehicles may not enter park after 8am or before 4pm. No breakdown of booths allowed before 4pm.
- Paved driveway inside Downtown Park is for entering & exiting only...not for unloading!
- You will have 10 minutes to unload & remove your vehicle, then you may set up your booth.
- Only weights & sandbags may be used to secure tents. No stakes will be allowed in the ground.
