



The Arts Council of Moore County & Southern Pines Parks & Recreation Dept. invite you to be a vendor at the 47th annual **AutumnFest** on **Sat., October 4, 2025** (9a-4p) in Downtown Park (145 SE Broad St., Southern Pines, NC). AutumnFest's goal is to give an authentic & family-friendly fair experience that offers handmade arts & crafts, food & live entertainment. Accepted vendors include, but aren't limited to, food, fine art, pottery, woodworking, metal, glass, fiber, photography, leather, jewelry, mixed media, & other handmade items. The AutumnFest Committee reviews applications in the order received & reserves the right to select or reject vendors based on the festival goal. The application deadline is 8/31/25 with notice beginning 8/1/25. Nonprofit & other non-handmade vendors may apply after 8/31/25 (space permitting). *Fees will be refunded if vendor isn't accepted.*

**Single outlet is one, 110-volt/20-amp, 3-prong receptacle. You must also provide your own extension cord. If you require over 20 amps per breaker, bring a generator.*

ARTS / CRAFTS / HANDMADE VENDORS:

All items for sale in your booth must be as described in your AutumnFest Vendor Application (attached), hand crafted without the use of kits, commercial models, & whose primary components are not manufactured. In addition to a complete application & payment, applicant must email (to Bridgett Sampson – email below) 2 photos of items that best represent what you wish to sell & 1 photo of your booth. Photos will not be returned & may be used for promotional purposes. Applications without images will not be accepted. Vendor notifications will be sent beginning 8/1/25. Space assignments & check-in instructions will be emailed beginning 9/5/25.

FOOD VENDOR REQUIREMENTS:

- **All food vendors MUST meet health/sanitation requirements according to G.S. 130A-247, return the Temporary Food Vendor Application or Exemption Permit to Moore County Health Dept. & pass inspection by the Moore County Health Dept. by 9/10/25 to receive your permit.**
- Food vendor must provide their own power/generator. NO ELECTRICITY is available on Broad St.
- Food Truck/Tent over 12'x12' are required to meet fire codes according to the [Fire Safety Standards](#).
- Maximum length for a Food Truck is 20' including the tongue.
- Food vendors must arrive by 7am on October 4, or make advance arrangements with Bridgett Sampson (phone/email below). Food trucks will be placed in order of their arrival.

Reminders for a successful & safe AutumnFest:

- AutumnFest will be held, rain or shine—**No Refunds & No Rain date**. \$10 processing fee will be withheld on cancellations requested by 9/19/25, after which no refunds will be granted.
- Due to the size of Downtown Park: Only 1 vehicle per vendor allowed in park at a time; Vendor has 10 minutes to unload & remove vehicle, then set up booth (Help is available upon request); No vehicles allowed into park between 8am-4pm. If you breakdown your booth before 4pm, you must walk it out.
- Vendor space size is 10'x10' | Food truck maximum length is 20' (including tongue).
- Not all spaces will accommodate a tent or trailer. It is **imperative** you complete the application accurately (especially if your trailer or tent exceeds 12' in height).
- Vendor must provide own equipment (tables, tent, chairs, etc.) & remove their own trash.
- Only weights & sandbags may be used to secure tents. No stakes will be allowed in the ground.
- Non-food vendor space set-up time will be 5:30-8am on Saturday, October 4.
- Paved driveway in the entrance into Downtown Park is only to enter & exit...not for unloading!
- Being dishonest on your application or misrepresenting what you sell/distribute from your booth may result in the immediate forfeiture of your vendor space, booth fee, & future participation in AutumnFest.

- **CASH/CHECK** payments must accompany the attached application (payable to "Arts Council-AutumnFest").
- **CREDIT CARD** payments must apply online at www.MooreArt.org/AutumnFest. A 3.5% non-refundable, convenience fee will be automatically added to all credit card payments.
